Please note that .JPG, .PNG, and .ODT files are not appropriate; all submissions will be submitted by the instructor to TurnItIn for academic integrity review.

Your Research Essay must address the following items:

- Topic selected (brief description)
- Historical background (e.g. When did this become an aging issue? Why?)
- Influence of demography (e.g. What role does the rapidly aging population play as related to your topic?)
- Contemporary aspects (e.g. Why is this an important aging issue now?)

Your paper will be concise and formal (academic) in tone. You must proofread your work prior to submission, and points will be deducted for poor writing quality as well as failure to use APA format.
